Being on the Board provides Members with an opportunity to help shape the future of our kindergartens, be involved in decision making, learn about Governance, participate in Professional Development opportunities and meet with others with a similar interest in early childhood education.

Board Members are recruited by:

- Election by the Members present at an AGM or
- Co-option on to the Board at any time during the year when a vacancy exists after the AGM

If you are interested in learning about what is involved in being a Board Member please contact the Board's President, Jessica Uri or the General Manager, Helen McNaughten.

To help you understand a little more about the role of a Board Member we will provide prospective Board Members with:

- an Induction Booklet and
- the Board Governance Manual
- the NKA Constitution

We invite you to attend a Board Meeting, so that you have the opportunity to meet the Board and observe the issues the Board is involved with. The next Board meeting is the **5 April 2017, 6pm**, 66 Kennedy Rd, Napier.

The process for election to the Board at an AGM is:

- Nominations should be received by the Association no later than Friday 24 February 2017 and must be made on the Associations' Nomination Form (as above)
- After we have received your nomination form your nomination must be seconded by a Board Member, so a meeting with one or more Board Members will be arranged for you prior to the 22 March 2017.
- With your nomination form you are asked to provide a brief letter of interest which should provide some information about yourself, why you are interested in joining the Board, what you would bring to the Board and what you would like to gain from the experience. This letter will be circulated to Association Members prior to the AGM.
- At the AGM you will be introduced to the Members who will have the opportunity to ask you any
 questions they may have regarding your standing for the Board.
- Members will vote on your nomination, at least 50% of the Members present at the AGM must vote in favour to be elected to the Board.

Each Board Member is elected for a 2 year term commencing from the date of election or re election at an AGM. Co-opted Board Members must stand for election at the first available AGM that occurs after they were co-opted.

If you would like to be nominated for a position on the Board and require some assistance with the process the General Manager will be only too happy to provide this.
