#### **ECE Strategic Plan**

The government has put out a strategic plan for consultation. In December, Association teachers and managers had the opportunity to attend consultation meetings hosted by the Ministry of Education.

The plan has many ambitious and positive goals, such as improving the ratio of teachers to 2 year old children (from 1:10 to 1:5), lifting and funding the minimum percentage of teachers employed, regulating the growth of new provision and developing a workforce supply strategy.

After consultation the finalised goals will be phased in over three periods some short term, medium term or long term. Medium and longer term implementation will rely on the government being re elected for subsequent terms.
