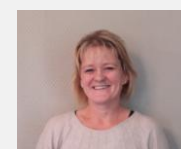

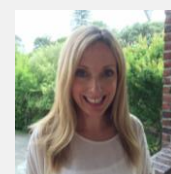

## What Our Board Does:

Board members are volunteers elected by our members to govern the Association and our primary responsibilities are:

- \* Development of the Association's Strategic Plan (our visions & long term plans for the Association)
- \* Employment & monitoring of the General Manager
- \* Monitoring of strategic outcomes
- \* Management of risk
- \* Monitoring of legal compliance
- \* Setting and reviewing of policies

## How Kindergartens Are Funded

Our kindergartens are not funded like schools are. Although the bulk of our funding is received from the government it is based on the numbers of children attending, their ages, the hours they attend, regularity of attendance, how many of their 20 Hours ECE hours are attested to us and the number of days we are open for. There is therefore a direct link between the number of children enrolled, and our funding.

Some additional funding is received (Equity Funding and Targeted funding for disadvantage) from the government for certain children, but not every kindergarten receives this. There are also constraints on how it may be spent.

We charge fees and request donations, which provide a small amount of additional income, and we apply for a number of grants to support kindergarten fundraising efforts.

When our kindergartens are closed for term breaks, Statutory holidays and Christmas, we receive no funding at all. We still have to pay staff salaries and wages though, and many other annual costs such as rates and insurance.

In 2010 the funding received for employing 100% fully trained and qualified teachers was cut, and reduced to funding only 80% of our teachers. We lost \$ 600,000 per annum overnight, and after 7 years finally had to pass some of this loss on to parents via fees and donation requests.

## Not for profit service

Napier Kindergartens is an incorporated society and a not for profit service. This means our primary objective is not to maximise profits or surpluses (which are available to investors as a rate of return on their investment), but rather to expend all the funds we receive into providing the best educational opportunities we can, at the most affordable price to our families.

Our financial decisions are not therefore purely profit driven although it is still important that we generate sufficient funds to cover our day to day costs, as well as cover future capital or emergency expenditure.

Approximately 80% of our income is spent on salaries and wages, the bulk of which covers teachers' salaries. In 2018 this meant that of our \$ 6.4 million income received, \$ 5.2 million paid the Association's employee salaries and wages.

Every other expense of operating our kindergartens has to be covered by the remaining 20% of income received (in 2018 this was \$1.2 million).

We ended the 2018 year with a \$ 127,601 loss and we are forecasting another loss for 2019.
