Kia ora tatou te whānau

Welcome to Term 3 and a special welcome to tamariki starting kindergarten for the very first time this term.

On the 19th June, at an Extraordinary General Meeting, a motion to rescinde and replace our Constitution with effect from the 14 October 2019 was passed. We thank our members for their time and attention to this matter, and in particular those who attended the Extraordinary General Meeting on such a dark, cold, winter's night.

There are now a number of matters we need to attend to in advance of the new Constitution coming into effect. We will begin by developing resources to inform prospective members of the process by which they may apply to become members, and of the rights and obligations attached to membership. We will be seeking feedback from parents on these resources to ensure we capture your valued views, so keep an eye out for the invitation to participate.

Since our last newsletter the Board has attended two board meetings and is preparing for two members to attend the next New Zealand Kindergartens Annual General Meeting in Wellington on the 6 September.

At each of our board meetings we consider and discuss our aspirations for kindergarten, receive reports from our General, Finance and Education managers and monitor the financial position of the association. Other matters are discussed on an 'as required' basis.

ERO is scheduled to commence reviews of our kindergartens in August and September. They may well be on site as you are arriving with your child, you are most welcome to have a chat with them if you wish.

Bette Christie Kindergarten now offers 7.5 hour sessions and an extended year service. They were open for the first time during the term break. The Board would like to acknowledge and commend the staff for how well this went. We have received really positive feedback from parents and teachers.

The Ministry of Education and NZEI were able to reach a settlement of the teachers collective agreement after four days of bargaining talks. Although we are not directly involved in these discussions we are pleased that pay parity with primary and secondary teachers has been agreed. Retaining pay parity with the compulsory sector demonstrates the value of kindergarten teachers and the role that they play in the early years of learning and development.

Measles

Measles is a highly contagious disease with potentially life threatening consequences. At least two cases have been reported in Hawkes Bay to date.

A person is infectious 5 days before a rash appears, and 5 days after.

First symptoms include:

- A fever
- A cough
- A runny nose
- Sore and watery 'pink' eyes
- Sometimes small white spots on the back inner cheek of your mouth

Please do not send sick children to kindergarten.

If your child is diagnosed with measles, please let your teachers know as soon as possible.

Napier Kindergartens – an Incorporated Society

Napier Kindergartens is one of 23,500 Incorporated Societies in New Zealand. We have been an Incorporated Society since December 1951. We operate under the Incorporated Societies Act 1908.

Incorporated societies are membership based organisations that have a separate legal identity from their members. This means that its members are not liable for its financial debts and that the society is able to continue operating, even though its membership may frequently change.

There are a number of rules that apply to Incorporated Societies such as:

- They must have a minimum of 15 registered members
- They must be not for profit organisations
- They cannot distribute profits or financial benefits to their members

A society is allowed to trade and actively seek to generate income for the purpose of its cause however must operate in line with the reasons for which it was set up.

A society is allowed to make a profit as long as its primary purpose for existing is not to make profits. In Napier Kindergartens any profits we make are held against future expenditure such as kindergarten repairs and maintenance, replacement of capital items, unexpected expenditure or emergencies, employee redundancy payments and maintaining low costs for our kindergarten services.
